THE IMPORTANCE OF FIT

- Tight-fitting respirators must seal to the wearer's face to provide the expected level of respiratory protection
- Achieving a proper fit means that air is passing through the filter media. Without a tight, secure seal air will take the path of least resistance, going around rather than through the respirator.
- A respirators Assigned Protection Factor (APF) is only valid if the respirator fits correctly. Without proper fit testing there is no way of knowing if the respirator provides the advertised level of protection for each individual worker
- It is essential that fit tests are performed on all employees when employer-mandated respirators are used in the workplace
- OSHA stipulates that fit testing of employees must occur on a consistent annual basis - as specified by 29 CFR 1910.134
